## OceanaGold (Philippines) Inc. Reports Third Quarter 2024 Operating and Financial Results and Declares Second Dividend

*(All financial figures in United States dollars unless otherwise stated)*

(MANILA) OceanaGold (Philippines), Inc. (PSE: OGP) ("OceanaGold Philippines" or the "Company") reported its operational and financial results for the three months ended September 30, 2024. ### Third Quarter Highlights

- **Declared dividend of \$0.0138 per share (equivalent to ₱0.81 per share** assuming an exchange rate of ₱58.16 Peso per US Dollar<sup>1</sup>) for the quarter. **On an annualized basis**, this equates to a **dividend yield of approximately 20.6%**<sup>2</sup>.
- **Produced 27,900 ounces of gold and 3,400 tonnes of copper.**
- **Third Quarter Revenue of \$102M, Net Income of \$3.6M, and Earnings per share of US\$0.00**
- **Exploration permit for the FTAA area renewed for five additional years**
- 2024 guidance updated to 104,000 to 108,000 ounces of gold produced

Atty. Joan D. Adaci-Cattiling, President of OceanaGold Philippines, said "I am very pleased to declare our second dividend since becoming a public company in May. The dividend declared this quarter equates to an annualized yield of over 20%<sup>2</sup>. Gold production increased by 21% compared to the prior quarter and optimization work to increase mining rates from the underground is on track to achieve 2mtpa by the end of the year. We remain focused on safely and responsibly delivering our updated production guidance while generating returns for our shareholders."
